## LIVESTOCK QUALITY ASSURANCE TRAININGS

Livestock Quality Assurance (LQA) is required to show livestock at the county fairs in the RVED. All beef, swine, sheep, and goat exhibitors are **required** to attend at least one class. Bucket calf, horse, and dairy exhibitors are **strongly** encouraged to attend. This year a showing and fitting clinic will be incorporated into the training. The showing and fitting portion is not required, but highly encouraged to attend. We have chosen one specie per location (except the Washington location having both Beef and Dairy). 4-H/FFA members are invited to attend the showing and fitting clinics at all locations, but will only be required to participate in one LQA training. The showing and fitting clinics will take place following the LQA training. You may attend the training of your choice even if it is not the location of your home county. #### **AK-SAR-BEN NOMINATIONS**

Please contact Katelyn Brockus at the RVED-Washington office for DNA kits and nomination information. DNA kits must be ordered in advance, so please be prepared prior to weigh in dates with this information. Additional stock show information can be found at www.rivercityrodeo.com/stock-show.

#### **HORSE ID PAPERS**

All horses that are planning to exhibit at County Fairs or District Horse Show must be identified by May 1<sup>st</sup>. Horse and owner information must be completed on the 4-H Horse Identification Certificate (P1039). This certificate can be found at the local extension office. This form requires member, parent, owner (if leased), and Extension Agent signature. Attached must be a color profile picture that includes 4 feet/legs and the horses head turned towards the camera. Previously enrolled horses can be rolled over to the current year with Extension Agent's signature if informed by the 4-Her.

#### **DISTRICT HORSE SHOW**

The 2015 District Horse Show is set for July 1, 2015 at the Saline County Expo Center. Online entries are due by June 1<sup>st</sup>. Check in is available the evening of June 30<sup>th</sup>. No late entries! Horse level testing must be completed by entry time to compete at the District Horse Show and State Fair.

#### **4-H BUCKET CALF PROJECT**

The Joint Fairs Committee has agreed upon a few small changes for the 2015 showing season. There will be two divisions Junior (7-9 yr) and Intermediate (10-12 yr). Bucket calves must be born between Jan 1<sup>st</sup>, 2015 and April 30, 2015. You must own your calf by May 1<sup>st</sup>, 2015. Bucket calves will need to be tagged and pre-entered using the 4-H Bucket Calf Identification form.

Bucket calf exhibitors will participate in interviews before ring showmanship. Calves may or may not be required (this will be at the superintendents discretion). No show sticks will be allowed in the bucket calf show. Show halters are ENCOURAGED!

The second year bucket calf project calves (that were shown as 4-H Bucket Calves last year) may be shown in market or breeding heifer classes if they qualify. Second year bucket calves must follow the ownership and tagging/identification requirements of the other beef animals. Second year bucket calf exhibitors participate in beef showmanship with their respective age division. Second year bucket calf exhibitors (both heifers and steers) will compete against each other in the ring for an overall second year bucket calf award.

You do not have to weigh-in at your respective county fair location. These are the only check-in times available for beef market animals. If your animal is not tagged at county-weigh in, they will NOT be eligible to show at county fair. Don't forget Commercial Breeding Heifers will need an EID tag for state livestock show nomination! Feel free to bring your Commercial Breeding Heifers to a county weigh-in for tagging!

Cost per tag is:

-Bucket Calves & Breeding — \$2.00 per tag,

- eID for Market Beef & nominated heifers -\$3.00 per tag.

#### SHEEP AND GOAT WEIGH-IN

April 22, 2015- Washington, Washington County Fairgrounds, 4:00-6:00pm

May 2, 2015- Belleville, Republic County Fairgrounds, 9:00-10:30am

May 2, 2015- Concordia, Cloud County Fairgrounds, 12:00-1:00pm

May 2, 2015- Clay Center, Clay County Fairgrounds, 2:30-3:30pm

You do not have to weigh-in at your respective county fair location. In order to participate in the rate of gain contest, all market sheep and meat goats need to be tagged with an official 4-H EID tag and weighed at county weigh-ins to be eligible. All market animals must be tagged at a county weigh-in to be eligible to show in their county fair.

#### **SWINE WEIGH-IN CHANGES**

Due to the risk of diseases prevention, swine projects will **NOT** be weighed in and tagged at any of the locations this year. EID tags and applicators will be available for pick up at your local extension office. After the 4-H/ FFA pig is tagged, a picture must be provided with the readable EID tag inserted into the ear. This picture must be submitted via e-mail to <u>kbrockus@ksu.edu</u> by **MAY 2**<sup>nd</sup>. ## LIVESTOCK PREMIUM SALE QUALIFICATIONS

In order to qualify for the Fair Livestock Premium Sale, qualifications have been put into place. Please be sure to plan ahead and make sure that you meet these qualifications **prior to July 1**<sup>st</sup>.

4-H members must attend a minimum of 3 club meetings (this does NOT include: Project Meetings, 4-H Council Meetings, Jr. Leader, or Ambassador Meetings), complete Youth Livestock Quality Assurance training, and participate in 3 approved activities listed on the RVED Fair Livestock Premium sale form (for details on the approved activities contact your local extension office). Activities MUST be completed within the current 4-H year (October 1-June30). Each 4-H member is responsible for completing his or her form and returning it to their Club Leader by **July 1<sup>st</sup>** in order to be eligible to participate in their County 4-H/FFA Livestock Premium Sale or Project Auction.

FFA exhibitors must attend a minimum of 3 chapter meetings, complete the Livestock Quality Assurance training, and complete 3 of the approved activities listed the RVED Fair Livestock on Premium Sale form (for details on the approved activities contact your local extension office). Activities MUST be completed within the current FFA year (September 1-June 30). Each FFA member is responsible for completing his or her form, having it signed by the FFA advisor/ instructor, and returning it to their local extension office by July 1<sup>st</sup> in order to qualify and participate in the Livestock Premium Sale or Project Auction.

# KANSAS STATE FAIR AND KJLS NOMINATIONS

Electronic ear tags (EID) will be required for ALL market and commercial breeding animals in the nomination of state livestock shows. In order to ensure commercial breeding animals be tagged, bring those animals with you to an official county weigh-in. Market beef nomination deadline is May 1<sup>st</sup>. Commercial Heifers, Market Lambs, Commercial Ewes, KSF Market Hogs, KJLS Barrows, Commercial Breeding Gilts, Market Goats, and Commercial Does nomination deadline is June 15<sup>th</sup>. A nomination form and declaration form is also required and can be found at <u>www.youthlivestock.ksu.edu</u>. These forms and DNA envelopes will be provided at county weigh-ins.

# TRACTOR AND MACHINERY SAFETY TRAINING OFFERED

Federal Law requires youth ages 14 and 15 to participate in a Hazardous Occupations Training and become certified in order to work for hire for anyone other than their parents. Youth must pass a safe tractor and machinery operation program to be certified. To meet this requirement the RVED will conduct a district-wide Hazardous Occupations Trainings/Tractor and Machinery Safety Training in May. The training provides trainees with knowledge of tractor, machinery, and other farm hazards to reduce the farm accident rate. It also provides sufficient information to pass a written examination and an opportunity to demonstrate their ability to pass a safe tractor driving examination.

The training will be Saturday, May 9, 2015 from 8:30 am to 4:30 pm at CTI John Deere in Concordia.

Youth must pre-register at any RVED office by Monday, April 27th. Cost of the course is \$20 and includes materials and refreshments. You must provide, name, address, date of birth, and contact information as well as pay the fee at registration time.

Youth must complete assignments before coming to class, must attend the entire day, and then must complete a driving requirement in order to receive certification. Contact Kim Larson with any questions.

## SHOOTING SPORTS SCHEDULE

The schedule for the remainder of the year with all shoots at the Cloud County Fairgrounds in Concordia is as follows:

March 15-Shoot beginning at 2pm

April 12-Make-up Shoot at 2pm

April 26-Shoot beginning at 2pm

May 31-Shoot and "Fair Shoot" beginning at 2pm

#### June 7-Last "Fair Shoot" beginning at 2pm

It is suggested that the Washington and Clay County 4-Hers start at 2pm and Republic and Cloud at 3pm. This will help to alleviate the rush at 2pm. All 4-Hers are required to sign in with the coordinator and pick up their name badge before shooting. 4-Hers will sign in with the instructor at their discipline and return the name badge to the coordinator when they are done for the day.

**Fair Shoot:** There will be 2 shoots this year. 4-Hers must sign up with the coordinator for the date they want to do their Fair Shoot, provided they have attended the minimum number of shoots. 4-Hers must attend four shoots in order to participate in the Fair Shoot. May 31st will be a practice shoot or it can be the 4-Her's Fair Shoot.

In order to be eligible to be a county champion, 4-Hers are required to participate in the following :

- Seniors must do four out of five disciplines
- Juniors must do three out of four disciplines

If Shooting Sports needs to be cancelled due to the weather, notice of cancellation will be posted on Facebook, the River Valley District webpage, and announced on KNCK, KCLY, KREP, and KNDY radio stations.

# RVED FACEBOOK PAGES UPDATES AND TIPS

There is a great deal of buzz about social media and the pros and cons of the various formats such as Facebook, twitter, etc. Here at K-State Research and Extension, River Valley District we made a decision several years ago to develop and utilize the River Valley 4-H Facebook page as a means to provide up-to-date information and reminders to 4-H families between newsletters as well as a means to promote 4-H and publicize the great work of our 4-Hers here in the district. Regardless of what you read every day in the news about the rise and/or fall of the various social media, Facebook remains a valuable informational tool for our program. As always, we encourage our 4-H families to follow all the rules for Facebook use, especially concerning the age of account users.

We want to take this opportunity to answer a few common questions.

\*I am new to 4-H or Facebook. How do I find the River Valley 4-H page? – If you are new to 4-H, be sure to like us on Facebook and start getting our Facebook updates on your news feed. Go to facebook.com and search for River Valley 4-H.

\*I haven't seen any 4-H posts on my news feed lately. What happened? – Facebook, like most internet based businesses, does a great job in tracking the things you like. The more you interact with someone on Facebook, the more likely any post they make will show up first in your news feed. If you never like or comment on a post or page, then over time any post made by that person or business may not show up on your page. So, to keep us a priority on your Facebook page, just hit the like button to our posts! We post something to Facebook nearly every day!

\*Can I post on River Valley 4-H Facebook page? – Only our page administrators on the River Valley District staff can post to the page. If your club would like to add something to the page, please contact your local 4-H Program Manager, our 4-H Agent, or Kim Kolman in our Belleville office, who manages our web pages.

\*Can I comment or ask a question on the River Valley 4-H Facebook page? – When our Facebook page was started in 2010 we asked our 4-H families to keep the page positive! GREAT JOB! For the most part, our posts should not prompt a lot of comments unless it would be to congratulate youth/staff on good work. Those are certainly OK. We DO ENCOURAGE QUESTIONS!! Over the years we have had many of you shoot a question to us over Facebook that has allowed us to clarify for everyone! We have also had inquiries about 4-H from those interested in joining. We certainly encourage that sort of dialogue.

\*Does K-State Research and Extension, the River Valley Extension District, or Kansas 4-H have Facebook pages? They certainly do. Just go to <u>www.ksre.ksu.edu</u> and <u>www.kansas4h.org</u> and follow them on Facebook, twitter or other social media. Go to facebook.com and search River Valley Extension District and like our district page to keep up with all of our programming not related to 4-H and Youth.

\*Can our Club use Facebook? – Many clubs are successfully using Facebook as a means of communication. We suggest that clubs use a private Facebook group so that only those in your club can see the posts. It would be good to invite the local 4-H staff into those private groups as a means of keeping them informed of what you have going on in your club!
